When benefits allow, Kaiser Permanente will reimburse 50 percent of the allowable on problem focused E&M office visits or home visits with modifier 25 when billed with a preventive medicine examination. Preventive medicine examinations will be reimbursed at 100 percent of the allowable.

Billing/Coding Guidelines

All claims must be billed according to Centers for Medicare & Medicaid Services (CMS) guidelines.

Codes included in this policy:

- E&M office visits (99201-99215) when billed with modifier 25
- Home visits (99341-99350) when billed with modifier 25
- Preventive medicine examinations (99381-99397)

Policy Definitions

Problem Focused E&M visits – Includes a history of the chief complaint of the present illness or problem, examination of the affected body area or organ system, medical decision making, counseling and/or coordination of care.

Preventive Medicine Examinations – Includes a comprehensive age and gender appropriate history of patient's past, family, and social history, examination, counseling/anticipatory guidance/risk factor reduction interventions, and ordering of lab/diagnostic procedures.

Frequently Asked Questions

- Q1: Why is Kaiser Permanente reducing the allowed amount on the E&M visits when billed with a preventive medicine examination?
- A1: There are certain elements of the preventive medicine examination that are duplicated in the E&M visits. These elements include obtaining vitals, certain portions of taking the patient history, and preparation of the exam room to name a few.
- **Q2:** Why is Kaiser Permanente reducing the allowed amount on the E&M visits instead of the preventive medicine examinations?
- **A2:** Kaiser Permanente is reimbursing the greater valued preventive medicine examination at 100 percent of the allowed, the E&M visits are the lessor valued service.
- Q3: A member has an appointment with the primary care physician for a preventive visit and also discusses a medical condition. The provider codes for both the preventive exam (99395) and an E&M exam (99211-25). Will both services be allowed?
- A3: Yes. Kaiser Permanente will allow the covered E&M exam at 50 percent of the allowable when billed with a preventive exam. Kaiser Permanente will allow the preventive exam at 100 percent of the allowable.
- **Q4:** A member has an appointment with a physician to discuss a medical condition. The provider codes an E&M exam (99214). Will the service be allowed?
- **A4:** Yes. Kaiser Permanente will allow the covered E&M exam at 100 percent of the allowable when billed without a preventive exam.
