#### **Authorization Code Ranges Format Update**

Over the next couple of months, we will be reviewing and revising the Published Authorization Code Ranges to expand them to include all related codes for the 'Referral Reasons' available on Affiliate Link. You will continue to see changes to these pages until this review is complete. The information contained in these pages is informational and does not guarantee coverage or payment.



When checking to see if the code will be covered as part of the requested service, you should answer these four questions using the indicated resources:

- 1. Does it require preauthorization or medical necessity review?
  - See the Preauthorization Code Check tool
- 2. Is it in the service range of the requested service?
  Check the Published Authorization Code Ranges
- 3. Is the code part of your provider contract?

  Review the Provider Manual and your own provider contract
- 4. Is the code part the member's benefit?
  See the Member Eligibility and Benefits Inquiry

#### HEDIS® Medical Record Review Season: February – May 2022

From February through mid-May 2022, Kaiser Foundation Health Plan of Washington will be conducting HEDIS medical record reviews on members enrolled in a Kaiser Permanente plan in 2021 to measure the quality of care provided to our members. Our medical record reviewers will be contacting your office to request remote access to your electronic medical record system (preferred), and/or request that medical records are faxed or mailed. We appreciate your assistance in providing access to the medical information as requested. Your prompt response will ensure that your

group's HEDIS measures accurately represent the high quality of care that you provide to our members.

#### Clinical Chart Validation Short Stay Reviews to begin soon



Kaiser Permanente, in partnership with Cotiviti, will be expanding the Clinical Chart Validation (CCV) reviews to include Short Stay reviews. The Short Stay reviews will be performed on a prospective (prepay) basis. As with the CCV DRG reviews, Cotiviti will send medical records requests for selected claims, along with clear instructions on how to submit the records directly to them. Once the review is complete, you will receive a determination letter. If you wish to dispute their findings, instructions will be provided on how to submit a reconsideration request.

# New clinical review criteria for coverage of vocal cord surgery for members with gender dysphoria

Effective April 5, 2022, Kaiser Permanente has implemented clinical review criteria for vocal cord surgery, including pitch lowering or pitch elevation surgery, for members with gender dysphoria. Referrals must be submitted by the Kaiser Permanente Gender Health Case Management team. Criteria for coverage include, among other indications: parameters for speaking fundamental frequency, a prerequisite of consistent engagement with voice



therapy for at least 6 months that does not result in the desired pitch, and member agreement to close follow-up post-operatively. # New clinical review criteria for coverage of facial and body hair removal surgery for members with gender dysphoria



Effective March 1, 2022, Kaiser Permanente has implemented clinical review criteria for facial and body hair removal for members with gender dysphoria. Clinical review criteria for hair removal for members with gender dysphoria have been revised to include indications for body hair removal which was previously considered not medically necessary. #### Lung Cancer Screening Guideline updated with new age range

The <u>Kaiser Permanente Lung Cancer Screening Guideline</u> has been reviewed and updated, and now reflects <u>the U.S. Preventive</u> <u>Services Task Force recommendations</u> released in March 2021.



Annual lung cancer screening with low dose computed tomography (LDCT) is now recommended for patients aged 50 through 79 (previously 55 through 74) who meet all three of the following criteria:

- Have at least a 20-year (previously 30-year) pack history, and
- Currently smoke or quit less than 15 years ago, and
- Have no significant comorbidities that would preclude surgical treatment or limit life expectancy
