#### Get ready – more authorizations upgrades going live on August 17<sup>th</sup>!

We received an overwhelmingly positive response to the launch of our new authorization code check tool that we introduced in July. We are pleased to announce we're ready to launch the remainder of our improvements on Monday, August 17<sup>th</sup>.



These upgrades will include:

- More user-friendly processes, better tools and information to initiate and track referrals
- Updated, user-friendly and enhanced online experience for submitting and managing referrals
- Ability to attach documentation to a referral request
- Changes to the current process for authorizations, including the default maximum number of visits and duration allowed in a single visit
- Authorization service code ranges available online

#### Kaiser Permanente walk-in pharmacy opening in Bellingham on August 20, 2020



Kaiser Permanente is expanding access to members and customers in Whatcom County with the construction of a new pharmacy located at 189 Telegraph Road in Bellingham, Washington. The new facility will open on **August 20, 2020**. Along with providing pharmacy services, the new location will offer vaccine administration and rapid medication (same day) delivery with plans to implement a curbside prescription pick-up service.

# <u>Kaiser Permanente will not reopen CareClinic by Kaiser Permanente at Bartell</u> <u>Drugs locations</u>

Following the rapid adoption of, and increasing demand for, virtual care across Washington state as a result of the COVID-19 pandemic, Kaiser Permanente is moving forward with the permanent closure of CareClinic by Kaiser Permanente at Bartell Drugs locations, which were temporarily closed in March during the statemandated stay-at-home orders.

**Effective October 1, 2020,** Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc. (Kaiser Permanente) are directing genetic testing to Invitae Corporation (Invitae) for in-network coverage for non-Medicare members when the requested test(s) are available at Invitae.

#### Changes to medical necessity review criteria for phonophoresis

**Effective October 1, 2020,** Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc. (Kaiser Permanente) will implement medical necessity criteria for phonophoresis.

#### Changes to medical necessity review criteria for sports hernia surgery

**Effective October 1, 2020,** Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc. (Kaiser Permanente) will implement medical necessity criteria for sports hernia surgery.

#### Changes to medical necessity review criteria for Transcatheter Aortic Valve Replacement (TAVR)

**Effective September 1, 2020,** Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc. (Kaiser Permanente) are changing the Transcatheter Aortic Valve Replacement (TAVR) clinical review criteria to allow coverage for all patients with documented severe, symptomatic aortic valve stenosis, regardless of operative risk.

# <u>Changes to medical necessity review criteria for Monitored Anesthesia Care during gastrointestinal endoscopic procedures</u>

**Effective September 1, 2020,** Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc.(Kaiser Permanente) will enforce existing prior authorization requirements for Monitored Anesthesia Care (MAC) and a change has been made to the medical necessity criteria for MAC during gastrointestinal procedures to require an American Society of Anesthesiologists (ASA) risk-stratification of class IV.

#### Changes to medical necessity review criteria for Micronutrient Panel Testing

**Effective September 1, 2020,** Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc., (Kaiser Permanente) will implement medical necessity criteria for Micronutrient Panel Testing.

#### Changes to medical necessity review criteria for Neonatal Intensive Care Unit (NICU) admissions

**Effective September 1, 2020,** Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc. (Kaiser Permanente) will implement medical necessity criteria for NICU admissions.
