Affiliate Link Tip: How to use referral template reasons and when to use the comment field

To avoid processing delays and/or potential denials, please follow the instructions in this <u>How to use referral template reasons</u> job aid regarding the reason for referral when submitting a request on Affiliate Link. Choosing a Reason for Referral ensures the highest auto-adjudication of the request. If you are unable to locate the appropriate reason on the authorization code range, use Other - Provider Detailed Comment for manual processing.

Ensuring access as we relocate Bremerton employees and patients

In-person mental health and wellness services at Kaiser Permanente's Bremerton facility have been relocated to nearby, convenient care locations on the Kitsap Peninsula. Bremerton team members have moved to nearby clinical facilities or been assigned temporary remote work privileges. Impacted patients have been notified and are continuing to receive mental health services from their existing provider virtually or in-person at one of our nearby Kaiser Permanente facilities. Kaiser Permanente Plan/Network Crosswalk resource



Have you ever had difficulty corresponding the particular Kaiser Permanente *plan name* with the appropriate network for an enrollee? The resource document linked above can help navigate the many Kaiser Permanente plan names to their respective *network name*. We know that some large hospital systems have used the crosswalk grid to inform their EPIC medical records system for our members' different plan types and

networks. When a member presents for care with their Kaiser Permanente member ID card, the plan name on their card can be cross-matched using this resource with the corresponding network.

<u>Labcorp is now a preferred provider for genetic testing codes 81420</u> and 81220

Effective September 1, 2022, Labcorp has been added as a preferred provider for genetic testing codes 81420 and 81220. No authorization will be required when you send your patient to Labcorp for these tests.





No change in submitting radiology orders to Kaiser Permanente Radiology

The implementation of Affiliate Link (Tapestry), the updated referral request system accessed through One Health Port, had no impact on the process for ordering radiology internally **within** Kaiser Permanente. The only change was the method for sending referrals externally when appropriate.

Please note that, if you are referring a patient from an external clinic to Kaiser Permanente for radiology, you must fax the request using the Radiology Request form found on our provider site.

Radiology orders **within** Kaiser Permanente are made via Epic. Epic routing functionality sends the order to the appropriate local clinic team or the Kaiser Permanente Radiology Appointing Center. If that team determines that the test should be performed externally for any reason, the team submits an external referral request. This request was previously submitted via the Kaiser Permanente provider site, but now it is done directly in Epic Tapestry using Referral Entry. The radiology teams have numerous templates built to help them enter external referrals.

Once an external referral is entered and authorized, the external provider who is being referred to can access Affiliate Link through our provider site to see the status of the referral and, in some cases, receive an authorization or denial notification electronically.

COVID-19 vaccines safe for people who are pregnant



New research published in the New England Journal of Medicine found that COVID-19 vaccinations during pregnancy were not associated with increased risk of serious acute adverse events, such as blood clots, low platelets, or other serious conditions. The study supports a growing body of data that shows the vaccines are safe for people who are pregnant.

Missed clinic visits limit appointment availability and result in lost opportunities for patients to receive care. Kaiser Permanente Washington recently partnered with the advanced analytics team at KPWHRI's ACT Center on a learning health system project to predict and prevent missed visits.
