Summary of Care communications restarting



When we launched Affiliate Link in 2020, we inadvertently interrupted the clinical referral communication, also known as the Summary of Care (SOC), which was automatically sent to a contracted provider when a member paneled at one of our Kaiser Permanente medical centers is referred to that provider. We have now resolved this issue and plan to re-implement these authorized referral communications in June. Please see our Summary of Care

Clinical chart validation short stay claims reviews to begin soon

Kaiser Permanente, in partnership with Cotiviti, will be expanding the clinical chart validation (CCV) reviews to include short stay claims reviews (1 – 3-day stays). The short stay reviews are similar to the DRG reviews and will be performed on a prospective (prepay) basis. As with the CCV DRG reviews, Cotiviti will send medical records requests for selected claims, along with clear instructions on how to submit the records directly to them. Once the review is complete, you will receive a determination letter. If you wish to dispute their findings, instructions will be provided on how to submit a reconsideration request. Additional details on the reviews along with a start date will be coming soon.

Cotiviti is a Business Associate of Kaiser Permanente Washington as defined in 45 CFR, Section 160.103 of the Health Insurance Portability and Accountability Act of 1996 ("HIPAA") and will perform its responsibilities on behalf of Kaiser Permanente Washington in full compliance with HIPAA requirements.

Apria implementing a new process for Phillips Bipap/CPAP Recalls



On June 1, 2022, Apria will implement a new process for Phillips Bipap/CPAP recalls for existing and new patients. For requests made prior to June 1, 2022, Apria will continue to support the additional 2-year limited replacement commitment for Kaiser Permanente member requests for equipment validated to be beyond repair. However, Apria will decline replacement requests within the 2 to 4-year range for any other

reasons. After June 1, 2022, Apria will respond to requests for replacement equipment in accordance with the standard manufacturer's warranty.




Interventional radiology referral template is live



The long-awaited rollout of the interventional radiology template is here! This template can be used to order Interventional Radiology for a variety of referral reasons and will allow for the highest auto-adjudication of the referral reason listed. An <u>interventional radiology service range</u> document has also been created to identify what CPT codes are included in each referral reason when authorized.

You can search for Radiology, Interventional or a combination to return a match for this new template:



The template will offer a list of referral reasons to choose from, with the "Other – Provide Detailed Information in Comments" as an option if none of the CPT codes are included in the referral reason ranges offered. Please choose the appropriate place of service by clicking the magnifying glass. The field will default to Office.

Osteoporosis Guideline updated

Kaiser Permanente's <u>Osteoporosis Guideline</u> has been reviewed and updated. Changes to the guideline recommendations were minor, with updates to:

- Lab tests recommended for ruling out secondary causes of osteoporosis, and
- Populations who should be screened for osteoporosis.



The updated guideline features a new shared decision-making tool for osteoporosis medications: Osteoporosis and Osteopenia: Medication Options.

Weight Management Guideline updated



Kaiser Permanente's <u>Weight Management Screening and Intervention Guideline</u> has been reviewed and updated. The guideline addresses prevention, screening, diagnosis, and interventions for both adults and children/adolescents. With this update, the focus includes using patient-centered communication and promoting healthy behaviors (exercise, consuming nutrient-dense foods, adequate sleep) rather than recommending weight loss for all patients.

Major changes

- A new section on **weight stigma** provides tips to help providers minimize weight bias when caring for and communicating with patients.
- A new section recommends consideration of comorbid eating disorders.
- Intermittent fasting, Noom, and WW have been added to the list of weight-loss diets.
- Shared decision-making for weight-loss medications is now recommended and includes discussion of the medications' benefits and harms, lack of long-term data, and potential for out-of-pocket costs.
- Weight-loss medication list: Semaglutide (Wegovy) has been added and has stronger evidence
 of effectiveness than other medications on the list. Lorcaserin has been removed due to an
 increased risk of cancer with its use.
