#### Biosimilar adalimumab-atto (Amjevita) now available!

**ADALIMUMAB-ATTO (AMJEVITA)** was the first FDA-approved biosimilar to adalimumab (Humira). Amjevita was approved by the FDA in 2016, but it was not until recently that Amjevita, manufactured by Amgen, was launched to market. With its availability and with the support of our doctors, specialty providers, and pharmacists, Kaiser Permanente of Washington has made Amjevita our preferred adalimumab product.

Your Kaiser Permanente members were sent a letter with this exciting news, so they may contact you with questions or ask for assistance getting a new prescription for Amjevita.

#### New toolkit offers guidance and resources for people with persistent pain

The Center for Accelerating Care Transformation (ACT Center), part of Kaiser Permanente Washington Health Research Institute (KPWHRI), recently released a new resource for people living with persistent pain. Called the *Toolkit for Managing Persistent Pain*, it provides practical tips to help anyone living with ongoing pain.

The freely available toolkit is designed to support people wherever they are in their pain management journey - from learning about ongoing

pain and management strategies, to preparing for a medical appointment and then navigating the health care system. It describes how persistent pain impacts body and mind, explains the roles of patients and care teams in managing pain, and provides self-management resources such as journal prompts, trackers, and tools to prepare for medical appointments. The toolkit closes with a list of books, websites, and other additional resources. Everything included in the toolkit is free for anyone to download and use.

The Integrated Pain Management (IPM) project team– made up of KPWHRI researchers and four patient partners who are Kaiser Permanente Washington members living with ongoing pain – co-designed the toolkit. The toolkit is written from the perspective of the patient partners.



"We are experts on living with ongoing pain, and this toolkit is guided by our personal experiences. Our goal is to help other people living with pain," write the patient partners.

The IPM project team works with patients, care teams, and leaders at Kaiser Permanente Washington to provide whole-person care for people with pain and provide safe alternatives to opioids. Many of the resources created by the team, including provider scripting, reference guides, and patient education materials, are available on the Quality Resources page on our provider site under "Pain and opioid management."

#### Biosimilar adalimumab-atto (Amjevita) now available!

#### Why is this change happening?

- This change to using biosimilar drugs supports Kaiser Permanente's mission to provide highquality, affordable health care services to all our members.
- Amjevita has the same active ingredient, works the same way in the body, and is just as safe and effective as Humira for the treatment of medical conditions.

#### How does this affect your patient(s)?

- Amjevita is placed on a lower tier and is covered as a more cost-effective medicine under their pharmacy benefit plan.
- For patients with Commercial coverage, starting **April 25, 2023,** Humira will only be covered under their pharmacy benefit plan if they have tried and failed Amjevita.
- Amgen patient financial support is available for Commercial members using Amjevita.

#### How does this affect you?

- Begin e-prescribing Amjevita for patients with Kaiser Permanente insurance.
- If your patient is currently receiving Humira, please submit a new e-prescription for Amjevita.
- If your patient has already tried Amjevita and it did not work for them, please submit an authorization to continue coverage for Humira.

## HEDIS<sup>®</sup> medical record review season: February - May 2023

From February through mid-May 2023, Kaiser Foundation Health Plan of Washington will be conducting HEDIS medical record reviews on members enrolled in a Kaiser Permanente plan in 2022 to measure the quality of care



provided to our members. Our medical record reviewers will be contacting your office to request remote access to your electronic medical record system (preferred), and/ or request that medical records are faxed or mailed. We appreciate your assistance in providing access to the medical information as requested. Your prompt response will ensure that your group's HEDIS measures accurately represent the high quality of care that you provide to our members.

## Viewing contracts in Eligibility & Inquiry tool on Affiliate Link

**AS YOU KNOW, WE INTRODUCED** the ability to view member contracts on the provider portal under Eligibility & Benefits Inquiry last year. We wanted to remind you that there will be a short delay in your ability to view the contracts as we load the new 2023 contracts. The expected timetable for viewing new contracts will be:

- 50% of contracts will be available by January 31st
- 95% of contracts will be available by February 28th
- The remaining 5% of contracts will be available by March 31st

#### Effective April 1, 2023

Changes to medical necessity review criteria for Genetic Screening and Testing (PDF)

Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc. (Kaiser Permanente) are revising existing criteria and implementing medical necessity criteria for Genetic Screening and Testing.

### Changes to medical necessity review criteria for MRI cervical (PDF)

Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc. (Kaiser Permanente) are updating the clinical review criteria for MRI of cervical spine.

#### Changes to medical necessity review criteria for certain elective surgical procedures (PDF)

Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc. (Kaiser Permanente) will implement level of care review for certain elective surgical procedures.

### Breast reconstruction free flap procedure (PDF)

Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc. (Kaiser Permanente) will not reimburse services for breast reconstruction free flap procedure when billed with HCPCS codes S2066; S2067 and S2068 unless otherwise specified by the specific contract terms. These HCPCS codes are reimbursable under CPT code 19364. Canalith repositioning procedure (PDF)

Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc. (Kaiser Permanente) will reimburse Canalith repositioning procedure CPT 95992, when the procedure is billed with CMS approved diagnosis codes.

#### Laboratory payment policy (PDF)

Claims processed by Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options; Inc. (Kaiser Permanente) will include, but are not limited to, the following criteria when processing laboratory claims.

#### Effective May 1, 2023

Changes to medical necessity review criteria for thoracic spine Magnetic Resonance Imaging (MRI) (PDF)

Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc. (Kaiser Permanente) will implement medical necessity criteria for MRI of the thoracic spine for non-Medicare patients.

#### Changes to medical necessity review criteria Pharmacogenomics (PDF)

Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc. (Kaiser Permanente) is updating the clinical review criteria for Pharmacogenomics testing.

#### Effective June 1, 2023

Changes to medical necessity review criteria for Intensity Modulated Radiation Therapy (IMRT) (PDF)

Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc. (Kaiser Permanente) have revised the clinical review criteria for Intensity Modulated Radiation Therapy (IMRT) for non-Medicare members.

#### Changes to medical necessity review criteria for Stereotactic Radiation Therapy (PDF)

Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc. (Kaiser Permanente) have revised the clinical review criteria for Stereotactic Radiosurgery for non-Medicare members.

#### Changes to medical necessity review criteria for PSMA PET Scans (PDF)

Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc. (Kaiser Permanente) will implement clinical review criteria for PSMA PET Scans.

Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc. (Kaiser Permanente) are updating the clinical review criteria for PET Scans.

#### Changes to medical necessity review criteria for total hip arthroplasty (PDF)

Kaiser Foundation Health Plan of Washington and Kaiser Foundation Health Plan of Washington Options, Inc. (Kaiser Permanente) will implement clinical review criteria for total hip arthroplasty for all non-Medicare members and will review Medicare members against CMS criteria.

Changes to medical necessity review criteria for miminally invasive sacroiliac joint (sij) fusions (PDF)

## Change in opioid refill threshold



#### What is the change?

The refill threshold for opioid medications will be changing from 75% to 85% effective April 1st, 2023. This means that members will need to have used up at least 85% of their medication before a refill can be covered.

#### Why are we making this change?

This change will help us better manage the dispensing of opioid medications and ensure that they are being used appropriately. It will also help us stay in compliance with federal and state regulations.

#### What does this mean for prescribers?

Pharmacy may reach out to prescribers if patients are trying to refill their opioid prescriptions before 85% of the existing supply is consumed, or if patients are going through their refills faster than expected.

This does not affect prescriptions that specify a length of time they should last. For example, any prescription saying "to last 28 days" will not be filled until 28 days have lapsed.

## Kaiser Permanente 2023 drug formularies

**THE KAISER PERMANENTE DRUG FORMULARIES** are the cornerstone of medication therapy, quality assurance, and cost containment. The formularies are developed by the Pharmacy and Therapeutics (P&T) Committee.

You can find formulary decision highlights from the most recent P&T Committee meetings on the Kaiser Permanente provider website.

#### **Kaiser Permanente has 7 formularies**

The table below outlines some of the major differences in these formularies. A closed formulary design describes a formulary in which preferred medications are covered and non-preferred (non-formulary) medications are generally not covered. Coverage of non-preferred medications is available through an exception process. An open formulary design describes a formulary in which both preferred and non-preferred medications are covered; however, preferred medications are available at a lower cost share for patients.
